- 2) Acceptance of Minutes of the 26th Annual General Meeting, 27 November 2021.

- 4) Financial Report: 2021 / 22

The Secretary/membership officer has sent out three (3) reminders to all members to renew their membership for 2022

Recently removed from the membership list are those who have been unfinancial for more than 3 years.

Therefore, the committee needs to re-engage with those who joined last year and have not renewed, as well as attempting to revitalize our membership to attract younger members.
